## Why do Masons wear white aprons?

The Encyclopedia of Freemasonry (c.1873)  
by Albert G Mackey

Lamb. In ancient Craft Masonry the lamb is the symbol of innocence; thus in the ritual of the First Degree: "In all ages the lamb has been deemed an emblem of innocence." Hence it is required that a Mason's apron should be made of lambskin.

In the high degrees, and in the degrees of chivalry, as in Christian iconography, the lamb is a symbol of Jesus Christ. The introduction of this Christian symbolism of the lamb comes from the expression of St. John the Baptist, who seeing Jesus, Lamb of God"; undoubtedly prophetic compare the suffering on the cross to a lamb under the knife of a butcher. In the vision of St. John, in the Apocalypse, Christ is seen, under the form of a lamb, wounded in the throat, and opening the book with the seven seals. Hence, in one of the degrees of the Scottish Rite, the Seventeenth, or Knight of the East and West, the lamb lying on the book with the seven seals is a part of the jewel.

Dear Members of PPMC:

There are several areas in PPMC that make it very difficult for emergency vehicles to quickly respond to 911 emergencies. Each second an emergency vehicle is delayed could have an impact on saving a life.

When an emergency vehicle approaches and you are blocking passage, you should attempt to:

--Check for pedestrians, cyclists, vehicles and any other obstacles, then pull over if safe to do so.

--Pull over as far as safely possible.

--Stay calm and be alert, as there may be other emergency vehicles coming.

--Pedestrians should stay off the road until the emergency vehicle has passed, ensuring it is safe before crossing.

If these tips are followed, unnecessary delays will be avoided and a life may possibly be saved!

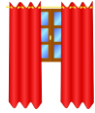

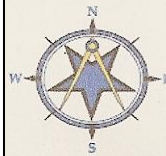

## **Narrative of 17 April Board Meeting**

I arrived early and the small social hall was locked but Ray Hoffman has a key (since he is the Bingo King) and let us in. I counted 25 members in the audience. 16 (64%) of those attend Tuesday coffee.

John Mancini questioned why the Fred Dunn-Ruiz petitions were discussed in closed session and Gayle said that it wasn't meant for secrecy...it was just done that way. I think, and I may be wrong, that the Board decided not to adopt those changes which mean that if Fred wants them on the ballot, he has to collect 40 signatures.

Remember, everyone, this is my take only on the actions of the Board. To get the "real scoop", read the minutes in the Bulletin.

Cyndy gave her managers report which included that all defibrillators are now updated; the office sent out notices to people who were late getting their dues cards to the office....and many, many of those notices were sent in error. She made a public apology to those who were inconvenienced.

Personal allotment files - one should be able to access them immediately. There is a waiting period of, I believe, 10 days for official files...i.e. minutes of meetings, reports, etc.

The basement has been organized for the flea market; Cyndy also personally reviewed the staking John Demsen did on his own allotment and found it to be accurate.

She talked about abandoned cars (cars have been abandoned in Sections 4 and 6) and we have a contract with a towing company. Signs stating that abandoned cars will be towed had to be posted at the front and back entrances

Drains have been cleared; there was a water leak in Section 6 (across from Carol Blum); all wires in the sirens are completely repaired.

Gayle announced that the motorcycle petition received 52 signatures, so that issue will be on the next ballot.

Sue Lovelace stated, that with the proposed budget, we would have a net income of \$5,020.00 Budget was approved.

The water "window" was discussed and people wanted to know when it will be open and closed. Gayle stated that she didn't know yet what the window would be. She said, "We have one chance to fix this and to fix it right so it doesn't happen again."

Shirley Moore reported on recreation and said she had a great meeting with an excellent turnout. The committee decided to do the traditional things

but suspended the quaker regatta for lack of interest. The next meeting is Saturday, April 24 at 2 p.m. She plans to invite the youth to attend and get their ideas and suggestions.

Char Reynolds, talking about the flea market, mentioned she had a small article in the Bulletin and full page in the PIP. She asked for ideas as to how the proceeds should be spent. For the sale, she requested items in good condition, clean, and please, PLEASE, please mark your bedding! (twin, full, queen, king)

John Mancini spoke about bylaws and publishing proposed changes two times in the Bulletin.

The Park has a new employee insurance policy which is better for the employees and cheaper for the Park.

Work on the Social Hall has been put off until the weather is better.

Six 911 calls....4 in the park and 2 outside. Jim and Dianna Cook, as well as Fred Dunn-Ruiz were complimented on their work for CERTS.....7 people are attending CERTS training.

Four incidents were submitted for mediation ; 2 cannot take action because the parties would not agree to mediation and 2 did agree.

### **Open Forum**

Someone asked if the bylaws could be posted on the official website. Gayle will talk to Carla about it.

Our 9 month CD is coming up for renewal and the best we could get is 1.61% at Rabobank.

Cheryl Dangreau was very much offended by the no dog pooping signs. Cyndy talked about it and said she was amenable to change.

George then spoke. He said he received an unsigned packet trashing one of the candidates running for the Board. He said it was totally uncalled for; Ray Hoffman spoke up as he, too, received a packet and said that as far as he was concerned, the sender of that garbage is 10 or 100 times worse than the subject of the garbage. Another person said that anonymous letters are in the same category.

My thoughts: When Gayle announced the candidates submitted by the Nominating Committee, she asked that a clean campaign be run. This is not MY idea of "clean." It's disgusting, hurtful and if it ever comes to light who did this cowardly act, they should be brought up on Masonic, Shrine and Eastern Star Charges. That is MY idea and MY feeling only.

The meeting adjourned around noon.

## Hornitos Lodge

During a recent trip to Mariposa, CA, Carol and I had the pleasure of becoming acquainted with the Inspector for the Masonic District that includes Hornitos Lodge #98. Being the historian for that famous Lodge, he agreed to conduct a tour of their old Lodge building, which we found most interesting.

Hornitos, a town made famous during the gold rush era, once boasted a population of 15,000, but with the playing-out of the gold mines the area became a ghost town and now has a remaining population of 65. The Masonic Lodge building, built in 1855 by Italian stone masons, was used by a variety of businesses, and when it was purchased in 1873 by the Masons it had most recently been used as a saloon. The Lodge has the distinction of being the smallest operating Lodge in California, with a Lodge room that is 17' 6" x 29' 6" in size. The Lodge has an active membership of 71, none of whom live in Hornitos, but they commonly travel a distance of an hour or more to faithfully attend their meetings. On the day of our visit they had conferred the first degree to two new candidates.

One of their former Past Masters held the distinction of having served for 30 years as the Master of that Lodge, followed during the next 20 years as being their secretary.

A number of years ago they expanded their Lodge by excavating a basement beneath it, which is just large enough to accommodate a few tables for their monthly dinners. In the process of doing the excavation they transported the soil to a nearby river, worked that soil, and recovered



enough gold to pay the cost of the project. More recently, funded by generous donations, they spent about \$30,000 and completely restored the building. The building is now on the National Registry of Historic Places, and is a California Point of Historical Interest.

I would encourage all Masons who are traveling in the historic Highway 49 gold country to take the time to visit this ghost town and view the old Lodge building. It is less than a half-hour drive out of Mariposa. And, if your time should coincide, they meet on the second Saturday of each month.

## MONEY TALKS – Maximizing CD Income

We all know that, the longer the maturity of a certificate of deposit (CD) the higher the interest rate one receives. Most financial institutions do not offer maturities beyond 5 years. I will confine my discussion to maturities of 1-5 years.

That 5-year rate looks nice but will tie up ones money for 5 years. One year CD's only tie up your money for a year but don't pay much interest. I would like to show the reader how to spread the money equally over CD's of maturities from 1-5 years whereby 20% of your CD's mature each year with the funds being available. In addition you will earn the high 5-year CD rate for all the certificates. The system is called "laddering". It will take you four years to position all the certificates at the five-year rate but from then on all CD will earn the 5-year rate. Here is how it works.

For illustration, let's assume you have \$10,000 to invest in CD's.

Year One - You buy 1-5 year CD's putting \$2,000 into each one. In April 2010, here are the best rates you could have received by shopping around:

1 year – 1.90%; 2 year – 2.05%

3 year – 2.65% 4 year – 3.00%

5 year – 3.39%

Year Two - Your 1-year CD has matured. With the funds, buy a 5-year CD. Your other four CD's are a year older and have turned into 4-year, 3-year, 2-year and 1-year CD's. Your 4-year CD is earning the 5 year rate and so is the new CD you just purchased.

Year Three - Another CD matures and you replace it with a 5-year CD.

Each year you buy a 5-year CD with the funds from the matured CD and by year five all your CD's are earning the 5-year interest rate. From here on you buy only 5 year CD's. If you need money, you take it from the maturing CD. If you have extra money, you add it to the 5-year CD you purchase. You get the general system, which can be modified to meet each individual's needs.

**Now go put your CD money to work!**

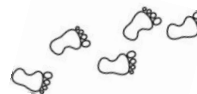

### FIVE Things You Didn't Know About Your Cell Phone

**FIRST Emergency** The Emergency Number worldwide for Mobile is 112. If you find yourself out of the coverage area of your mobile network and there is an Emergency, dial 112 and the mobile will search any existing network to establish the emergency number for you, and interestingly, this number 112 can be dialed even if the keypad is locked.

### SECOND Have you locked your keys in the car?

Does your car have remote keyless entry? If you lock your keys in the car and the spare keys are at home, call someone at home on their cell phone from your cell phone. Hold your cell phone about a foot from your car door and have the person at your home press the unlock button, holding it near the mobile phone on their end. Your car will unlock.

### THIRD Hidden Battery Power

Imagine your cell battery is very low. To activate, press the keys \*3370#. Your cell phone will restart with this reserve and the instrument will show a 50% increase in battery. This reserve will get charged when you charge your cell phone next time.

### FOURTH How to disable a STOLEN mobile phone?

To check your Mobile phone's serial number, key in the following digits on your phone: \*#06#. A 15-digit code will appear on the screen. This number is unique to your handset. Write it down and keep it somewhere safe.

If your phone gets stolen, you can phone your service provider and give them this code. They will then be able to block your handset so even if the thief changes the SIM card, your phone will be totally useless. .

### FIFTH Free Directory Service for Cells

Cell phone companies are charging us \$1.00 to \$1..75 or more for 411 information calls when they don't have to. Most of us do not carry a telephone directory in our vehicle, which makes this situation even more of a problem. When you need to use the 411 information option, simply dial: 800 goog411? ; (800) 466-4411

This information should be printed and kept in your car, purse, and wallet. These are some things that can be done in times of grave emergencies. Your mobile phone can actually be a life saver or an emergency tool for survival.
