The idea of bringing a facilitator into a corporation to host a forum is a traditional business practice of successful companies, organizations and non-profit corporations. The Facilitator helps define and gain member ownership of an organization's goals, direction and vision for the future. This is an exercise regularly completed by most successful businesses. The process keeps organization visions and goals fresh and relevant.

The Facilitated Meeting Committee in Paradise Park came into being after a contentious attempt to censure and punish a Park member was aborted. It was hoped that a Facilitated Town Hall meeting could help our membership and governing board focus on the future of the Park in a positive and constructive way, and help to heal a divisive rift that has been plaguing the Park membership and the politics of the governing board. Member Cheryl Dangreau volunteered to chair the committee, whose sole purpose is to hold a onetime Facilitated Meeting. This Special or Ad hoc committee will then dissolve. If successful the Park will move into the future focused on a vision and goals endorsed by the membership, and supported by the Board of Directors.

A Facilitator was suggested at the Board of Director's meeting, a Dr. Marilyn Manning PhD, who proved to be not only a preeminent professional in the field, and member of Eastern Star, but was willing to give the Park a major discount for the meeting and preparation. Dr. Manning's offer was gratefully accepted by the Committee on behalf of the Park.

Funding for the Meeting is hoped to be covered by private donations, and our first donation has been received. Donations may be given to any Committee member, and a strict accounting of funds will be kept by Committee Treasurer, Shirley Radder. Our fund raising goal is \$1,000 and any remaining funds at the conclusion of the meeting will be turned over to the Board of Directors Treasurer, and these

funds restricted for use at future Town Hall meetings.

The Committee has been diligently polling the members of Paradise Park for concerns to be brought forward to the Meeting Facilitator. These concerns are being condensed into general talking points, are intended to be broad and general enough to cover all the concerns brought forward, and presented in a positive and constructive manner for discussion and hopefully solutions will be found.

Dr. Manning has requested the Committee complete a SLOT (Strengths, Limitations, Opportunities, Threat) assessment for the Park. The Committee feels that the entire process should be member driven, so input for the assessment will be gathered at an open meeting of the Park's members and residents at 7:00 on the evening of 9 February at the social hall. A copy of a SLOT assessment brief and worksheets was distributed with the minutes of the 2 February Committee meeting and posted on the Our Park and Official Park websites.

The Committee is working with Dr. Manning (who is currently on vacation in Mexico) to schedule a meeting date on a Saturday, hopefully in mid to late March or early April.

Please stay tuned. We need everyone to help with this project for it to work.

I have volunteered to organize an Ad Hoc Committee to plan a Town Hall Meeting. This dedicated Committee will work with our membership to create talking points. Our Committee has been formed to help Club Paradise Park Masonic understand and help deal with issues that are divisive and creating conflicts within our Park. Our Committee will work diligently to avoid bias and personal agendas within the Committee and the appearance of such outside the Committee. Our Committee will carefully document and report our progress to the members of Paradise Park Masonic Club through available Park websites and publications, both Park managed and private, to keep channels of communication open.

Committee Goals

Our Committee will accept input from all interested Park members, residents and regular visitors.

Our Committee will work diligently to avoid bias in our deliberations.

Our Committee will plan and hold a facilitated meeting open to all members.

Our Committee will select a qualified facilitator to run the open meeting.

Our Committee will use member input to develop a list of broad talking points, and meet with the selected facilitator to explain our issues within the park.

Our Committee will develop funding sources to fund the expenses arising from the facilitated meeting.

Our Committee will schedule, arrange a venue and advertise the facilitated meeting to members of Paradise Park through available Park websites and publications, both Park managed and private, and other appropriate media.

Recommendations for Park Governance, Park Management, By-Laws, Policy, Procedures and Rules will be provided to the Board of Directors and Park Management for action. A copy of those recommendations will be published and made available to the members of Paradise Park Masonic Club through available Park websites and publications, both Park managed and private.

New Fire Truck

Anybody notice the yellow fire truck parked outside the fire house and wonder why it's not inside? It's not inside, because there is no room....yep, the Park was able to get a great big yellow fire truck to replace our old "in need of repairs" broken one.

Brit Thompson (#147) suggested to Dennis Gloeckler (#467) and Butch Downing (#592) they check out grant possibilities with Fireman's Fund. They applied for the paperwork, the form was emailed to the office and Dennis, Butch and Annie filled it out,. Lo and behold, the grant was evaluated, approved and a \$5700.00 check came in the mail!

In the meantime, Butch's son in law subscribes to a magazine (I think it was Deals on Wheels) that has used vehicles for sale, noticed the fire truck and gave Butch the details. Butch called the owner, and was told he could find out the details of the truck by logging on to E-Bay. After much discussion between Butch and Dennis, even though the owners wanted \$4750, Butch was able to negotiate down to \$4500.00.

Friday Butch and Noni drove to Olancha, Ca (a six and a half hour drive), spent the night and drove back to Paradise Park the next day. Butch drove the truck to PPMC.

The truck is a 1985 Chevy E-One Pumper with only 32,025 original miles. It comes with Federal Signal Smart siren, Federal Vector Light Bar, Arrowstick, Klenwood TK-730, 32 channel narrow band capable VHF radio, and a 5,000 KW generator with 2 telescoping lights. New the cost was \$75,000.

The balance of over \$1,000 will be used to purchase turnouts (that's "uniforms" in fireman speak) and maybe some needed radios for the volunteers.

The members of the Park owe a debt of gratitude to Dennis and Butch and to Brit. If you see them wandering around, shake their hands and thank them.....

The following narrative portion, written by Dennis, was part of the application process:

Paradise Park Fire Department is a very unique fire department in that we are a privately-owned and funded, all volunteer Fire Department. We provide fire protection for the 390 homes of Paradise Park Masonic Club. PPMC is located 1.5 miles west of Santa Cruz, CA. in the Redwood forest between Hwy 9 and the San Lorenzo River.

Paradise Park Masonic Club is currently within the jurisdiction of Cal Fire. Cal Fire in turn has a mutual aid agreement with the City of Santa Cruz, and/or the City of Scotts Valley Fire Department who now responds to 911 calls from PPMC along with Paradise Park Fire Department.

This system works very well until a mud slide or tree falls and blocks one of our three access roads into PPMC. Such an event may delay or prevent an outside fire agency for access into PPMC at a critical time. This has happened numerous times in the past and will continue to happen in the future. The Paradise Park Fire Department has never been prevented access to any emergency due to our being located within the boundaries of PPMC.

Our fire truck is a 1982 one ton Dodge power wagon brush truck that we have kept in good running order until our last fire drill when our pump suffered a cataclysmic failure. We have searched suppliers and have found that it will cost us \$5,000 to replace the pump. This is the main reason that we are applying for this grant.

A special treat this year was a 6 piece wood-wind ensemble arranged for by Michael Sawley. Board Meeting of January 22, 2011

Since Myron and I signed up for Tuesday coffee, we had the key to the social hall. We decided to get there early to start the heater and to set up the agendas and signin clipboard. I had a stack of signs and 8 x 10 sheets of colored paper with "Who's Next?" "I Support Free Speech" support Myron." "Who's Next" was written on the chalk board and when Tim Heer walked in, he went over to the board and erased it. I challenged him on that and he that he had "freedom eraser"....which, I thought, was pretty clever.

The meeting was called to order at 9:37 with another sincere and gentle invocation by Sharon Simas asking for peace and guidance, which was followed by the Pledge of Allegiance.

Wow, there were 47 members present of which 43% were those who attend Tuesday Coffee.

Manager's Report

On 28 December, between 4-5 inches of rain was measured in a 7 hour period. The drain was overwhelmed by debris, and perhaps this debris was related to the Cal Trans work on Highway 9.

Installed drain on St. John's near Morgan and Gladding allotments.

It was moved to establish an ad hoc committee to study the new proposal from Comcast who has sent new agreement. Our previous agreement was dated November 2004.

A letter was sent to Fish and Game regarding the log jams in the River. Cindy reported the status appears to be unchanged, but she will follow up with phone calls.

The yellow fire engine pump is broken and it will take \$5,000 to fix it. Gayle spoke about another fire truck that cost \$10,000, but it might be too heavy for the bridge.

No news yet on new waterlines to the front of the Park

Staff needs to review social hall procedures.

Cindy would like a proposal to require people to go before the board for replacement fences.

Tony Averill thought all construction projects had to go through the manager and the building committee

Last year, an antique car club, drove through the bridge and used the picnic grounds. They would like to do this again on Saturday, February 12 at 3 p.m. There will be between 30-40 antique cars. Jim Clark reported the picnic grounds would not be available as the renovation of same is starting soon. It was suggested the recreation committee post flyers about the antique car event on the 12th,.

What was discussed next was, I believe, the reason so many people appeared today.... the Board decided to withdraw the earlier suggestion that Myron Coleman be suspended. Sadly, with the way the original suspension letter was written, signed by Gayle Logan Silva, Myron was never given any specifics as to what his crime was. When asked of the Board to explain, Gayle said, "Can't you figure that out?"

Sharon stated that a member should not have to come before the Board with the "threat" of suspension.

Additionally, Myron previously requested that the suspension be discussed in an open forum instead of closed session, and as of this morning, he had not heard (either by e-mail or phone call) that his request had been granted. His supporters were ready to stand outside the office prior to the closed meeting session and quietly demonstrate support for him, but didn't know whether the "suspension hearing" was to be in open or closed session. What a fiasco!

Bottom line.....no suspension.

In an effort to do away with negativity, the Board talked about a sort of "Town Hall" meeting format to bring our community together. The name of Dr. Marilyn Manning was mentioned and we were asked to "google" her on the World Wide Web. Dr. Manning has a PHD in psychology and has helped at least 400 corporations and groups.

Sharon Simas explained this concept and said that the Board was to stand back,

NOT be connected to this, and let the membership handle this function. She then asked for volunteers to Chair. Cheryl Dangreau volunteered with Gayle also volunteering. There were many murmurs of "no" when Gayle spoke up and again Sharon strongly suggested the Board step away and let the REST of the membership work on this.

Treasurer's report

We are functioning in the black; there is \$52,965 out in receivables which include past-due TADS, water loan payments, back taxes. It is imperative that we receive that money. Diana has tried to work with those who owe by suggesting payment plans and other ways of payment. Our only recourse is suspension and/or termination. Take note and pay your bills!

It was moved to have the water project report ready for the February Board Meeting.M/S/P To have this report audited by an outside vendor would cost \$100/hour. **Recreation** - Potluck tonight Katie and Hap are hosting with the gathering at 5:30 **Building report** - Getting cooperation from most of the members; there is an increase in septic tank and plumbing problems

Please bring projects to Tony Averill by phone call or written request.

Staking 11:10 to 11:25

Tree committee – discussed to remove the tree at Keller-Cannon allotment. Discussion by the Board ensued. The board will review the arborists report. Karen knew of two trees that have been removed with the stipulation that roots were also to be removed. Roots have not yet been taken out. Will be referred to next month.

Saturday, January 29 at 9 a.m. is the Bylaws Committee meeting and at 1 p.m. on the same day is the Recreation Committee meeting.

Mediation Committee needs more members and especially someone who would be willing to help with the paperwork.

Professional Management – hopefully by the February board meeting (or maybe March meeting) their report will be completed.

Picnic grounds - Jim Clark reported that finally the Committee is in a place where we can do something. We have volunteers

standing at the ready as well as licensed contractors.....raise the building...pour the slab....Terry Fitzpatrick will be doing the work.. inside of the shack will be niceput a new counter top outside....better lighting....handicap accessible bathrooms... The committee is meeting today. Jim emphasized that the committee does not want the park to bear any costs.

A committee was formed to come up with a procedure for background checks for approving new members. Mike Sawley and Mark Zevanove are on this committee.

Dam Committee - concern because the Committee has not turned in any funds earned. Karen was told that Kurt Diesner controls the money and the committee was fearful they would not be able to complete their task if they submitted the money to the office. Need the money on hand to complete the next step. Seems the situation of not receiving the Dam Fund monies is no further settled than it was last month. It was recommended to the Board that the committee not be allowed to hold any more fund raisers until those monies are turned in.

Historical Committee - Lisa Leong has some ideas for promoting the commercial use of our covered bridge. She will chair an ad hoc committee to investigate questions and answers regarding this endeavor. She suggested sending pictures of the bridge to advertising agencies. Cindy told about Mercedes Benz who wanted to use the bridge for two hours and were willing to pay \$3,000.00! Sadly they decided it was too far from San Francisco to come down to photograph.

ERT - Eight 9 1 1 calls reported since last Board meeting. Six for medical and two outside the park. We have two AEDs that are not functional. New ones are \$1400 to \$1700 apiece...to be repaired, it's \$100 an hour.

10 people signed up for ERT training over 15 January session.

Cindy requested that at year end, if there are any monies left over, that those funds might be set aside for the Manager's fund for repairs and emergencies.

Mark Zevanove talked to his buddy at Robobank about the 24 houses for sale in

the park. Robobank...may be willing to do financing for members on improvements. Nothing for sure, yet, but they are working on it.

Some committees were appointed for next year. The names were read too quickly for me to get all written down. Maybe they will be posted on the Official Web Site.

Best board practices – whistle blower protection policy....passed....(don't know what that is)

Adopted board member code of ethics

Since financial information is posted in the Bulletin, the Bulletin is now to be placed on restricted side of the official website, which is open only to members of the Park. One has to contact Karla and register for an account.



February 19, 2011

The February 19 meeting of the Board of Directors was called to order at 9:34 The invocation was led by Bob Morgan which was followed by the flag salute. Minutes of closed meeting were approved as read

Manager's report- Finished the roof of the covered bridge; Cindy was appreciative of the "divine" intervention of the spring-like window of weather. There were no live termites discovered. The rafters were replaced in some areas. There will be a full written report to all members by the next Board Meeting.

Cindy did a "show and tell" of the faulty wiring under the office There was even an example of an overhead light fixture with hot areas where one could have been easily shocked just changing the light bulb.

Main sewer line is in trouble, it's a 4" clay pipe.

Mark Z and John M thanked for work on the Comcast renewal agreement.

As a result of the inquiry letter our Manager mailed out, Fish and Game sent county officials to check on LWM. The Park was told Fish and Game does not have responsibility nor funds, but there are grants available. Suggested Board should hire a professional liaison to assist the river and stream committee to work out this process. -----Broken pump in fire truck; received

----Broken pump in fire truck; received grant from Fireman's Fund to purchase new truck (see article on page 6)...

Staff reviewed social hall procedures ----Confirmed discoloration in San Lorenzo River near Middle Beach is an iron deposit that is a natural occurrence and is not toxic.

Professional management – Cindy: "Lately more than ever I question what the goals are....discourse among the board members...discourse among the members." Cindy tries to stay positive, but it makes it difficult if not impossible to concentrate on her service to this community. She attempted to read a letter and stated she knew she was aware that speaking out as a manager is putting her position at risk. She was not allowed to continue as Gayle felt it was not the proper place or venue, so Cindy distributed her

letter/statement to the audience. (page 12) -----Gayle said what Cindy was doing was in retaliation as Gayle had thought to fire her.

Ray Hoffman stood and asked to be heard, was denied by Gayle, but went on anyway. He said the tape of "Myron" stalking Gayle, via golf cart (which Gayle insisted was 99% positive it was Myron), was actually Ray Hoffman, driving his brother in law around and stopped in front of Gayle's house to remove a branch from under the cart. He wanted that on record since Gayle had threatened to take it to the Sheriff.

Cyndy concluded stating she did not like getting involved in Park politics, but felt this move was necessary and turned in her signed petition for the recall of Gayle.

Budget \$39,000 to the good; \$924,902, in assets & \$1,511,835 liabilities. Our total equity is \$4,413,076

Water report, which was supposed to be available at the February Board meeting is currently being formatted. It will go to the Board on Tuesday.

.....Taking a more assertive role in suspension hearings – on people behind on their tads & assessments. They will be asked to come in & explain the situation

(At this point, Gayle asked Myron to stop staring at her....Myron denied that he was staring at her)

Director's spotlight award – Jan 2011 to Tiny and Bob Sands for creating a warm and wonderful holiday potluck in 2010 for the past 20 years.

Director's Report Sharon Simas which was read by Pat MacDonald. Sharon expressed concerns over unfair Board decisions, and how difficult it has been for her to work and do a good job in all good conscience. She also requested an outside auditor prepare the water report. The people doing the report have been offered assistance.. The report has been requested since last September with a petition signed by members asking for full disclosure. Her report will be attached to the official minutes of the meeting. At the end of her report, she presented her signature on a recall petition.

The Board decided this morning to wait from input from the Background check committee before proceeding with background checks. Discussion ensued regarding the water project, and more excuses were given as to why it has not been completed.

John Mancini suggested a summary done in about four pages. He felt the members wanted a broad brush about what happened in each section...was there a contract? Why was so much spent? People want to see where their money went. Diana said the report was done.

The Bylaws Committee was asked to propose a Bylaw that would not allow a member of the Board to also be a Park Officer. Gayle stated that Bosso said a Park Officer could not be President of the Board. Pat read her notes and that was not stated anywhere, but Gayle insisted Bosso said so.

Pat McDonald gave her report, which was also written, and added how she has tried repeatedly to get tapes of meetings with the Board and attorney Bosso and has not been given them. Cindy feels they should be kept in the office for safe keeping and not taken to Diana's house. Diana responded by saying that Pat should not be able to take home her laptop! To: Board of Directors, Paradise Park Masonic Club

I have worked as Manager of the Park for three years now. What I want to speak about today are some recent events that I cannot in good conscience ignore. My concern is that some of these actions, since they constitute violations of legal statues, can fall outside of the protection of our liability insurance and place the entire membership at risk for personal financial consequences. Some recent legal and ethical violations include:

1. Conflict of Interest

The Board agreed that the President should recuse herself from involvement in a conflict of interest issue involving a member. The President ignored this agreement, remained involved in the situation, and ordered the Manager to take action even though the specifics of her directions were not approved by the Board, nor reflected in the minutes, nor were they standard procedure by any means. For these reasons, I halted the action. I reminded the Board President that Vice President Simas was the "point person" regarding the dispute, and was told by Gayle Logan Silva that I "could step down if I didn't want to do this job."

2. Code of Ethics Violation

The Board President has used derogatory, verbally abusive and retaliatory actions toward fellow Board Secretary Pat McDonald and Vice President Sharon Simas who openly expressed opposition during discussions in Board meetings. This behavior violates the Code of Ethics to "Approach all Board issues with an open mind, prepared to make the best decisions for those we serve."

3. Procedure Violations

Board President Gayle Logan Silva is calling "special" Board meetings without informing all Board Members.

4. Attempted Violation of Civil Liberties

Board Members Gayle Logan-Silva, Diana Cook and Karen Eneboe ignored PPMC attorney's warning that suspension against a member for his private website could result in a SLAPP (Strategic Lawsuit Against Public Participation) ruling. A SLAPP ruling involves First Amendment rights and again could result in serious personal financial responsibility for PPMC members should a civil court find that our Directors action was illegal. I appealed to the Board to explore alternative methods in dealing with challenging social issues, and I voiced my opposition to this action. I was then told that it was not the Park manager's duty to protect the Corporation. As a result of my differing opinion in this case, President Gayle Logan Silva has threatened to terminate me for "insubordination". I understand that my position as Manager is to carry out Board directives. I have done so to the best of my ability. However, this example begs the broader question of all of us. To whom is the Board accountable? It is for this reason I speak to you today.

I'm aware that speaking out on theses issue may put my position as Manager at risk, however I fear that the uncontrolled actions of some of our Board members in pursuit of personal agendas, especially our Board President Gayle Logan Silva, are putting our community and the welfare of our members needlessly at risk. The responsibility of the future of the Park lies within each of us.

Report of Director McDonald February 19, 2011

As a Member of a Board of Directors, I am well aware of my role, my rights and my responsibilities. I have studied the governing documents of Paradise Park and am fairly well versed in parliamentary procedure. I have many mentors that I can question in order to get more information. Additionally, as a Member of the Executive Council of Homeowners, I voraciously read books and articles on common interest developments like ours.

Because of the experience I bring to the table, this Director's report this month deals with things I feel this board is not doing, or not doing correctly.

First and foremost, the Board's job is to protect the assets of the Corporation for its Members – all 391 of them. For some of our members, their fully paid for home in Paradise Park is the bulk of their estate and net worth. Should they lose that asset for any reason, they would be homeless and dependent upon others. We have quite a few collective Members in that boat. That is a huge responsibility that the Board has and should always take very seriously.

This Director feels very strongly that the Board made some decisions based not on concern for the common good of the Membership but rather because of personal agendas and prior associations. Decisions were made without one piece of written evidence given – strictly on hearsay. Legal Counsel has advised against certain actions, yet the majority of the board voted contrary to that advice. This Director was prepared to resign her position had that decision not been withdrawn. Why? Because one must support the majority actions of the Board, but if one feels that it is an action so detrimental to the Corporation as to not be supportable, then the only ethical action for that Member to take is to not be part of the Board. Then they can speak out freely.

The Board has held at least two illegal meetings recently where one board member was not informed. Actions were taken in those meetings. Although this Director has requested minutes reflecting the actions taken, no summary has been forthcoming. These meetings were recorded, and this Director has requested copies of those recordings several times to no avail. Our Board President apparently was not in good control and shouted name calling complete with foul language during at least one meeting. Perhaps that is why this Director has not been privy to the proceedings.

At one of the meetings, the Board President warned the Park Manager to not talk to the bookkeeper. When she pointed out how absurd it would be to not talk to her staff, the manager was then warned that if she had any parliamentary questions or issues they were absolutely not to be discussed with this Director.

Because of these observations, and with a very sad heart, as a Member, I am signing the recall petition.

Share the Love

So here I am again with another inspired culinary revelation. On Thursday, January 27th, Shirley Reddick, Eduardo, America, Edgar and Gunner (Shirley's puppy) set out on a road trip to Arizona. After many stops along the way to exercise the dog and let the kids run off a little steam, they arrived at my house at 4am. Everyone was exhausted and went right to bed. They made the long trip to Arizona to visit with Juana. This would be the first time America and Edgar would get to see their mother in almost 2 years!

Friday was spent relaxing in the sunshine. I think this is the first time I have seen Eduardo smile or laugh. We tried to keep the kids occupied all day since we could only visit Juana on Saturday and Sunday.



Friday evening we went to dinner at Rustlers Rooste a fun restaurant with a spectacular view of Phoenix with the Superstition Mountains as a backdrop. As you enter you are on the 2nd story of the building. There are two ways to get to the dining room - via stairs or a slide. Eduardo and America chose the stairs while Edgar and I chose the slide. I heard a little velp and turned around to find that Shirley had also decided to enter via the slide. (in a dress!) I wish I would have had my camera ready for that! America and Edgar giggled all through dinner when they found out that had eaten appetizer they "rattlesnake." By the time dinner was over everyone was exhausted and couldn't wait until the next day.

On Saturday we drove to Eloy to visit Juana. Juana told us it would probably be best to arrive about 11am. We arrived at the center and were cleared through security immediately. Shirley was a little emotional and decided to wait outside and take care of Gunner. I went in with Eduardo and the kids and we were seated at a table waiting for Juana to arrive. The officer on duty knew that this was the first time the kids had visited so he set up chairs for them on the same side of the table where Juana would sit. Eduardo and I were seated on the opposite side of the table. We finally saw Juana enter the room and she took a minute to pass a piece of paper to the officer on duty. (Normally visitation is for 2 hours but she had spoken with someone who had granted her a 3 hour visit since she had not seen the children in such a long

As Juana approached our table, the kids grabbed on to her and wouldn't let go! She sat with them both on her lap and her face was squished up as she was receiving nonstop kisses from both kids! Eduardo and I were both in tears just watching them. The officer on duty came over to the table and watched the happy reunion. He then announced that as long as it didn't get too busy, he would extend the visit beyond the 3 hours. At that time, I went outside to give the family some privacy. Shirley and I played with Gunner in the parking lot and I finally convinced Shirley that she should go in and see Juana. It was very emotional for her but she finally agreed.

Thanks to the nice officer on duty - they were able to stay until closing and had a nice 4 1/2 hour visit. I was waiting by the gate when everyone came out and Edgar came running up to me and said "Guess what? I think my mommy likes me!" We all started to laugh - even though it was so sad to hear.

We returned on Sunday and decided to get there early and hope for another long visit. We arrived about 9am but we were only granted 3 hours as there were so many visitors that the visitation room was packed and the waiting room was overflowing. Again the kids were as close to Juana as they could possibly get. Shirley, Eduardo

and I did manage to get a few words in with Juana. We asked if there was any news about when her appeal would be heard and if there was anything at all that we could do to help her case. She told us what we already knew - that it is just a waiting game - no one knows when her case will be heard. She did tell us that it would be a good if we wrote letters to her Deportation Officer at the facility and that way he would know how much she is loved and missed. I asked her to send his name and address to me and I will ask Shirley Radder to post it in the PIP and have Myron post it on his website. About then we were advised that the 3 hours was almost up. Shirley and I left and gave Juana time to say goodbye to her family.

After leaving the detention center we stopped at the Casa Grande Indian Ruins. This proved to be a great diversion to help the kids get over missing their mom. America recently did a school report on the Indian Ruins in Arizona. She had a great time taking photos and learning about the different types of cactus that grow in the desert.

This visit was very emotional for everyone involved, but I think it helped to give Juana a little glimmer of hope. We still have no idea when her case will be heard as there seems to be no rhyme or reason to the way the Immigration Court works.

If you would like to help Juana and her family, please send a letter to her Deportation This Officer. has devastating to their family (and many of us in PPMC) and Eduardo works very hard to try to keep things "normal" for the kids. I know that they have a big support group here in Paradise Park. Many of us have taken this family into our hearts and homes. We know how great they are. This is no longer just about Juana. This has become a hardship on three innocent victims -Eduardo, America and Edgar. let the "powers that be" know how much thev mean to us. Please send a letter expressing your feelings to Juana's deportation officer. You can mail your letter directly to him or you can put it in my mailbox and I will send them off as a group. If you are not comfortable addressing a

letter to him directly, it was suggested that you could copy him on any correspondence that you send to Juana.

My backbone went limp, I burst into tears, as I didn't know Juana was allowed to have visitors. Long story short - Eddi and her husband, Harold, (402 Consistory Ave), have a home in Arizona, and invited us to

stay with her in Arizona and visit Juana. Other than the Brown's knowing Eduardo and family as working and being part of Paradise Park, we were essentially strangers. I later found out that Eddi had not really known Juana either - she had read about Juana being in Arizona and made a special attempt to get her address and arrange a visit. Had it not been for Myron's website, Eddi would never have made the initial visit that led to the children and Eduardo being able to visit with Juana after 2 years.

Last week, I drove and Eduardo, America, Edgar and Gunner (my 11 mo. old Lab Mix) left for Arizona. Eddi flew to Arizona to be there when we arrived and host our trip. I think that was truly remarkable.

We arrived approximately 4:30 am and she directed each of us to our rooms. I didn't even take my shoes off. We slept in the lap of luxury and woke up to a beautiful home, pool and outside hot tub, the red carpet was laid out and Eddi was most gracious - with the smell of coffee, bacon and all the trimmings. Eddi had her Suburban (pet and kid friendly) and enchanted us with her well- organized presentation of the local sites. We took the kids to a local park with a Merry-go-round Edgar and America were so and train. excited they stood in line to buy tickets, watched the train approach, and it suddenly stopped. It broke down and there would be no more rides for the day.

We headed back home as the kids wanted to play in the hot tub. The children and Eduardo laughed and played and we all spent hours enjoying our time. The kids thought it was so much fun to splash and play and sit up against the jets in the hot tub. We finally decided we should think about making lunch and realized it was already time for dinner.

America's birthday is February 12th, and she decided this year she would celebrate her birth "month" and not just her birth day. We went for dinner at the Texas Road House and let it be known that we were celebrating a birthday. After dinner they rolled a saddle to our table and instructed the birthday girl to sit in the saddle. Then

they asked everyone in the restaurant to join in and yell Yee Haw three times. America was thrilled and enjoyed all the attention.

The fun and joy on this trip never stopped. The highlight was our visit with Juana. The heartfelt warmth and joy of watching America and Edgar re-unite with their mother. For Edgar the visit was very natural as he gets to talk to his mom on the phone and we talk about her constantly - it was as if they had never been separated. For America it was a bit more emotional. She handled it very well. The love and endearment was obvious watching the 3 of them intertwined like Siamese triplets. For Edgar, leaving after the final visit was very matter of fact - like he would be back to visit soon. For America it was a little harder.

After the visit we tried to acknowledge America's feelings and make her feel special (as she is). Eddi thought it would be fun to take America out for a little "girl time" away from her "jabber jaws - steal the show" brother. She surprised her by taking her out for her first pedicure. America giggled and squirmed and said it tickled. She was so excited to return to the house and show us her purple toe nails. She and Eddi both had flowers painted on their toes.

On Monday we said goodbye to Eddi (who filled our car with treats and water bottles) and left for our drive home. I was driving and came to a sign that pointed to Los Angeles one direction and the Grand Canyon the other. I was in the lane for LA when I asked which way everyone wanted to go and the vote was the Grand Canyon (with a lot of whooping and hollering). I safely made a 5 lane change over and we were off to snow flurries, mountains and beautiful sites. We spent the night in Flagstaff and had to head to Walmart to buy warm jackets and hats as it was freezing cold. The next day we continued to the Grand Canvon and it was breathtakingly beautiful. The kids were so excited to see the Grand Canyon and the snow on the ground. The cold was discouraging and we had to climb back into the warm car.

This total experience filled me with a such a sense of Masonic love that I haven't felt since my husband's death. It brought

Well folks, the sheer walls were inspected by the County and we got a good thumbs up and a signature, time to attack the sheet rock was next. 5/8ths gypsum board (sheet rock) was applied over the sheer wall, and installed with 1 1/4 drywall screws with proper spacing, sheet rock is heavy and we had to construct some T post to help hold the gypsum up while we positioned it on the ceiling, 8 foot pieces were used. The walls were next and they were 10 foot tall pieces standing up on end, lots of measuring and fitting to get them right, drywall took about 5 days total. Tape and texture was next. We used an all purpose mud for the seams, butt ends, and texture. This made sanding a breeze.

I am currently applying the primer coat so the sheet rock will not absorb so much paint. I bought a 4 gallon bucket, which should give me pretty good coverage. Paint is next and we are going to use a basic white top coat. We will be ordering the new garage door soon. Its coming from a San Jose company, and is in stock. That's it for this month, see you all soon.
