So then dear readers, this long overdue communication will probably get to you in a somewhat untimely fashion in that this particular corres-pondence is all about the bubbly!

For those of us who do not confine ourselves to the holiday season with regard to bubbly imbibing, then this revealing spread should be viewed as, "not a moment too soon", or as they say, "enfin!"

And so for you....in the past 6 weeks I have made it my duty to taste test my way through no fewer than a dozen bottles of various forms of what we tend to call Champagne, to find the perfect bottle of less than bank breaking---but still luscious to sip sparkling wine.

I broke my taste testing down into two separate groups: over \$20 per bottle, but under \$40, and under \$20 per bottle. I did this because I realized that there were innumerable unsophisticated palates out there that, when seeking a decent bottle of bubbly for any occasion, they decide with their purses rather than palates. I also realized that there are so many poor souls out there wondering around a few days prior to new year's eye, looking for a decent bottle to take to the party, shunning those notorious labels that you remember from all the cheep wedding receptions you attended while in college, just to end up with a forgettable bottle, and thus probably a forgettable ho/hum evening.

And then I realized, oh dear, those poor souls need my help, and since I've been taking in the nectar of the Gods for a few decades now (with rapt attention) perhaps now would be a perfect time to lend my unwavering expertise.

Well rejoice! Here are the results of the grueling taste tests, if you want to hear more about all of the lineup, you'll have to tap the editor, and she'll tap me in turn. Just ask her what you 'd like to know, and I'll answer in the next Pip.

However, I will tell you now that the winner is a blend, not a single varietal.

For the "under \$20 per bottle" results: Charles De Fere, Jean-Louis Blanc de Blancs Brut is the winner. I also tasted these NV labels in this price range:

Gruet Blanc de Noirs Gruet Brut Gruet Demi Sec Gruet Extra Dry


Hands down, the Jean-Louis was far and away the single best sparkling wine for the price. It is produced in France by Jean-Louis Denois who is from a long established "Champagne" family. The wine is produced in Burgundy, which is just 20 miles outside the actual Champagne region and as I've already noted, this sparkling is a blend.

The nose is slightly fruity with hints of peach and apple. With the first sip you get crispy and the rich toast and mineral. Dry, but not too, and then a fullness in the middle that brings together the fruit, adds a little creamy lemon with a little yeast. The bubbles are larger in the middle to the end, but it is so luscious that you just don't notice---or if you do; you don't care. This wine is firm yet elegant. Every time...I serve it people ask where to buy it. And my dirty little secret is that it's so affordable that, #1 I buy it by the case when I can find it #2 It's so affordable that if you just feel like having a glass or two--you can leave the rest without quilt(if you do the guilt thing---which I don't)!

So ENJOY! Buy a few bottles when you find it, otherwise it'll be gone when you think to go back for more....heed this that I say to you.....and You can thank me later.

Oh yes, the price is around \$11.








### Behind the Teacher's Desk

The content of the letter and the attachments are fabrications. Please be assured that if any of the 'allegations' were true I would not have been appointed to my current position as Chief of Police.

Law Enforcement standards are very high in California and candidates are subjected to extensive vetting including FBI and State criminal history checks.

I believe I know the origin of the letter and those connected to it. I am contacting the Sheriff and U.S. Postal Inspectors to initiate investigations.
